Before I get you back on the road I just want to check your eyes, make sure that you're okay to drive the vehicle, um, and then we'll go from there, okay? So, if you can just get out and step behind the vehicle for me?

[00:14:13] Lucas: I explained why. It's just the, having you in the middle of the roadway, and you're backing up with no lights on.

[00:15:48] Lucas: So, can I just check your eyes real quick?

[00:15:49] Lucas: You wear contacts?

[00:15:53] Justin: I don't know, whatever my doctor prescribed me.

[00:17:31] Lucas: I'm not-- I never say anything about arresting you.

[00:17:34] Justin: - possibly.

[00:17:34] Lucas: But--

[00:17:34] Justin: Then, we're gonna go to court and then-

[00:17:37] Lucas: Why would I arrest you?

[00:17:39] Justin: - we're gonna turn the park up light- the backup lights on, and see if they come on or not.

[00:17:41] Justin: Three or four or five, six, nine months down the road.

[00:17:44] Lucas: Why would I, why would I arrest you right now?

[00:17:46] Justin: I don't know. You're already making a bunch of stuff up, man.

[00:17:51] Justin: So randomly, you're driving on this road-

[00:17:53] Lucas: All right, Justin. We can, we-we've been over that. At this point, I need to do my part of the job where I see how much you've been drinking.

[00:18:00] Justin: What I'm saying is I don't think you have probable cause to pull me over.

[00:18:03] Lucas: I think you can argue that in court all day long

[00:18:06] Justin: You're driving, you're driving on the road, on a complaint from somebody called me in 'cuz I was doing something at O'Malley's which has to do with some girls- girl.

[00:18:16] Lucas: Okay. In the state of Idaho, legally, I have to check your eyes before I put you back on that road if I Justin: you're driving under the influence of alcohol. If you don't let me do that, and you're completely stone-cold sober, you know what that means? That means you'll go to jail for obstructing. So, you can go to jail for obstructing, you can go to jail for DUI, or you can get back on your road and drive home if I think that that's okay. But the more you stall my time on the side of this road, the more likely you're gonna be behind the seat of my car in handcuffs and going to jail.

[00:18:40] Lucas: And you can argue that in court all day long. That's what court's for. I'm telling the judge what I saw. If the judge call me out on it-

[00:18:50] Justin: I observe X and Y going on. And then you hung that microphone up, and-

[00:18:59] Lucas: No, I-I told dispatch that I have observed a traffic offense and that I'm going to be initiating traffic stop on your vehicle for that offense.
